EXECUTIVE SUMMARY.

This meeting aim to sensitize the communities around the Mtego wa noti ward on safe techniques that can be used to keep elephants away from the village and keep them safe with their properties.

This was a one-day meeting which was held on 11th August 2023 at village meeting place in Mtego wa noti ward, participants were the District Forest Officer, Ward Executive Officer, Village Executive Officer, villagers and TADEO project staffs.

The structure and content of the meeting was prepared by TADEO secretary reviewed and approved by the project coordinator.

PROJECT SUMMARY.

Human elephant interaction is a complex and prevalent issue that occurs throughout the range of African communities around game reserves since elephants and people share the same habitat and this often lead to competition for the same resources by understanding this dynamic can help identify management strategies to protect both humans and elephants (Graham, 1973).

Human-Wildlife Conflict (HWC) especially Human-Elephant Conflict has become a pressing conservation and poverty issue in recent years in Africa, invasion of communities with wild animal's harms livelihoods of farmers, destruction of crop hence this deteriorates relation between communities and wildlife authorities and this precipitate hostility in the communities.

Experience from other regions suggests that it is unrealistic to expect total prevention of conflict so the strategy must be one of mitigation and integrated management to reduce the problem to levels that are tolerable by communities around game reserves.

The project relies on the following objectives,

Fostering human-elephant co-existence in communities around Kigosi-Moyowosi Game Reserve by,

After opening remarks from the district forest officer then project coordinator was welcomed so as to give explanation to the villagers on the technics that can be used to keep them safe from elephants and continues to promote the co-existence of human and elephants in the village.

Firstly, project coordinator thanked all villagers for their positive response regarding the meeting, after there project coordinator focused to educate the community on the following topic,

• Importance of co-existence of elephants and human in the community and nation in general.

With this topic project coordinator started by saying "elephants are good friends to all human being but they become angry once they have been disturbed by any means like blocking their way by force or chasing them noisily while hitting them", elephant faeces is one among good natural manure for plants, elephants attracts more tourist and from this the village do earn income through practicing tourism activities so elephants must be kept safe for betterment of the coming generation and the nation in general.

Safe methods of preventing elephants from harming the community.

With this topic project coordinator emphasized the community on planting peppers around their homestead and farms since elephants does not need pepper and this will help to keep their farms safe and prevent hunger in the community, if the community notices elephant presence in the village they must collect elephant dung, pile pepper onto the dung and burn it this will help elephants to leave the village quietly since the pungent smoke will release pepper residues into air and irritate elephants and the will leave without causing any harm to the community.

The community must take tobacco, mix with engine oil and ground pepper, this mixture must be smeared on ropes and surround them to the food garden this will prevent elephants from destroying the crops.

The community must focus on planting crops that elephants dislike like sisal around their farms and home steady also planting ginger.

 Protocols that must be observed when the community notices elephant presence in the community.

ACHIEVEMENTS.

- The project team managed to conduct the meeting as it was planned.
- All participants arrived early and the meeting started within time.

If the community notices elephant presence in their village the following must be done immediately,

- Village authority must be informed immediately.
- The district forest officer and district wildlife officer must be informed immediately.
- All villagers must stay indoors and keep quiet.

After being taught, the project coordinator welcomed the district forest officer for a word,

District forest officer insisted that all that have been tough must be taken into practice and this will help to keep the community safe always, from there then the meeting was closed officially and the TADEO project staff together with the district forest officer started the journey back to Uvinza town.


